### Get started in three easy steps

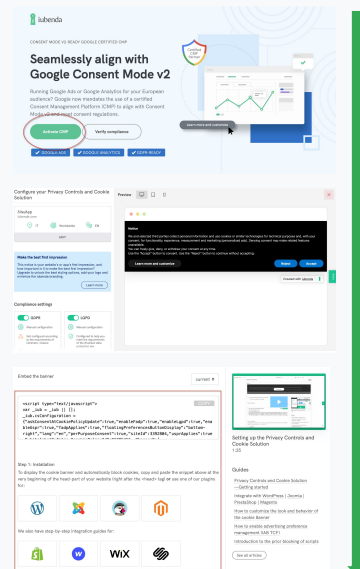
1. Visit [iubenda.com/google-consent-mode-v2-certified-cmp](https://iubenda.com/google-consent-mode-v2-certified-cmp), click on “Activate CMP”, and follow the wizard to create an account and set up the CMP. You can go for the automatic configuration tailored for your website by iubenda or customize any detail of your consent and cookie banner.
2. Choose one of the many integration options available: Copy/paste the embedding code in your website, use our GTM template, or go for one of our CMS plugins.
3. You're all set. Consent Mode is enabled by default with the iubenda CMP. No further configuration is needed.

No technical skills are required to use iubenda. The minimum level of expertise required is the ability to install your CMS iubenda plug-in or copy/paste the CMP embedding script in the <head> section of your website.
